ELIGIBILITY/LEAVE WITH PAY TO ATTEND

By law, each eligible employee is allowed **leave with pay** to attend up to two Retirement Planning classes. To be eligible, you must be participating in the Nebraska School Retirement Plan, and vested in the plan. You may not attend more than one seminar per fiscal year. (*See Neb. Rev. Stat. §84-1511*) Paid leave is handled through your employer, so be sure to connect with them.
