WHY A HALF-DAY?

SCHEDULE

ELIGIBILITY/LEAVE WITH PAY TO ATTEND

By law, each eligible employee is allowed **leave with pay** to attend up to two Retirement Planning Seminars. To be eligible, you must be participating in the Nebraska Retirement Plan, and vested in the plan. You may not attend more than one seminar per fiscal year. (See Neb. Rev. Stat. §84-1511))

SEMINARS WILL FILL UP QUICKLY

Advanced registration is required to attend an in-person seminar. Registration and fees must be received at least one week prior to seminar, so please plan accordingly. In-person seminars are subject to cancellation or a reduction in the number of participants at any time.

IF YOU NEED TO CANCEL

To receive a refund of your registration fee, you <u>must</u> notify NPERS of any cancellations or changes **AT LEAST TWO BUSINESS DAYS PRIOR** to the seminar date.

CANCELLATION POLICY

If a seminar is cancelled, registrants will be notified as soon as possible and offered a refund or the opportunity to attend an alternate seminar (if available).
