REGISTRATION

Registration and payment are required in advance and must be received at least one week before the seminar. **Seminars may fill quickly** and are subject to cancellation or reduced capacity.

CANCELLATIONS

To receive a refund, notify NPERS at least two business days before the seminar. If NPERS cancels a seminar, registrants will be notified as soon as possible and offered a refund or rescheduling option, if available.

ELIGIBILITY/LEAVE WITH PAY TO ATTEND

By law, each eligible employee is allowed **leave with pay** to attend up to two Retirement Planning classes, but only one per fiscal year. To be eligible, you must be participating in the OSERS Retirement Plan, and vested in the plan. (See Neb. Rev. Stat. §84-1511) Paid leave is handled through your employer, so be sure to connect with them.
