

STATE/COUNTY HALF-DAY RETIREMENT PLANNING SEMINARS

WHY A HALF-DAY?

This is **NOT** the regular full-day seminar that covers your retirement plan, social security, elder fraud, estate planning, and medicare. It is a shortened half-day format to accommodate members who only want information regarding their NPERS retirement plan.

SCHEDULE

Half-day seminars run from **8:30 am to 11:30 am**, with check-in beginning at 8:00 am. (no early check-ins). Materials are provided.

ELIGIBILITY / PAID LEAVE TO ATTEND

Eligible employees may receive paid leave to attend up to three Retirement Planning Seminars but only one per fiscal year. Must be active and vested in the Nebraska State/County Retirement Plan. ([See Neb. Rev. Stat. §84-1511](#))

REGISTRATION

Registration and payment are required in advance and must be received at least one week before the seminar. **Seminars may fill quickly** and are subject to cancellation or reduced capacity.

CANCELLATIONS

To receive a refund, notify NPERS at least two business days before the seminar. If NPERS cancels a seminar, registrants will be notified as soon as possible and offered a refund or rescheduling option, if available.
