Compensation 457(b) Plan: T. Cummings gave a brief overview of the process that is required for a county to request to participate in the Deferred Compensation 457(b) Plan. He stated Thurston County has met all the requirements to make this request.

Agenda Item 11 – Adoption of Experience Study Actuarial Recommendations: An exhibit was presented provided by CavMac on a proposed step down of the assumed rate of return from 7.0% to 6.75%.

- T. Zimmerman moved to withdraw the motion made at the February 24, 2025, PERB meeting to approve the Experience Study recommendations. Motion was seconded by G. Clausen. - A. Simpson moved to accept all the recommendations contained in the Experience Study conducted pursuant to Neb. Rev. Statute 84-1503 to be effective January 1, 2025, but separately step-down the recommended real rate of return from 4.65% to 4.40% as follows: to 4.60% beginning January 1, 2025, to 4.55% beginning January 1, 2026, to 4.50% beginning January 1, 2027, and to 4.40% beginning January 1, 2028 and thereafter; which will result in the nominal investment return stepping-down from the current 7.00%, to 6.95% beginning January 1, 2025, to 6.90% beginning January 1, 2026, to 6.85% beginning January 1, 2027, and to 6.75% beginning January 1, 2028 and thereafter. Motion was seconded G. Clausen. Members voted as follows: For: J. Elliott, T. Zimmerman, P. Bourne, G. Clausen, J. Curtiss, C. Neumann, A. Simpson, and L. Splattstoesser. Against: None. Motion carried.

Neumann moved to set the basis point fee in the State Deferred Compensation Plan used to pay plan expenses to 1.5 basis points while retaining the \$2.00 per account monthly charge effective April 1, 2025.
