

School Refund REPAYMENT FACTORS*



*As of July, 2023. Factors are subject to change over time.

Members have five years from their return to plan participation to complete the refund repayment process. Members must be actively employed at a participating employer and submit the one-time repayment application form no later than within five years after the date of such member's reinstatement, or 60 days prior to termination, whichever is earliest. Please refer to the plan handbook for further details on the application process.

Find the factor nearest the date of your refund, and multiply the gross amount of your refund by that factor. The actual cost of repayment will be determined by NPERS upon written receipt of a request for repayment.
