Stat.* §84-1511 for further details.)

Advance registration is required to attend a seminar. Please plan ahead accordingly. Your registration form and fees must be received at least one week prior to the seminar.

IF YOU NEED TO CANCEL

To receive a refund of your registration fee, you <u>must</u> notify NPERS of any cancellations or changes **AT LEAST TWO BUSINESS DAYS PRIOR** to the seminar date.
